Meet new friends, attend fascinating programs, and of course go birding!

This year's conference will be based out of Fort Collins, in the northern Front Range region. We'll be there at the absolute best time of the year for the maximum number of bird species—migrants, breeders, and residents. Along with the expected species, we are bound to find rarities.

Who should attend? Answer: Anybody who's interested in birds! Expert birders will be there to help beginners, intermediate birders, and anybody else who wants to learn about birds. We especially encourage young birders to attend, and we have several youth scholarships available. See below for details.

Our base of operations will be the Fort Collins Hilton, conveniently located along U.S. 287 a few miles west of I-25. That puts us less than an hour from timberline, prairie, and Wyoming. Along with lodging at the main conference site, there are plenty of other hotels and camping options quite close to the Hilton.

We are very excited that the keynote speaker at our evening banquet is Dr. Craig Benkman, the world's foremost authority on the Red Crossbill. Dr. Benkman will talk about the different "types" of Red Crossbills, several of which may be full species. This topic is of great relevance to Colorado birders, because several Red Crossbill "types" occur regularly in Colorado.

Other presentations will be given by Lynn Wickersham on the Colorado Breeding Bird Atlas, Jason Beason on Black Swifts, Tammy VerCauteren on Sludge Dump to Meadow: Making Conservation Happen, and Tony Leukering on "Nomenclature."

As usual, there will be an evening "Stump the Chumps" panel; come watch members of the Colorado Bird Records Committee writhe in agony—and learn about bird identification in the process.

At our banquet, there will be awards, announcements, and a brief members' meeting. Throughout the meeting, vendors will represent birding organizations, optics companies, and so forth. Join us, too, for an evening book-signing. Meet your favorite authors of books on Colorado birds. Note: The American Birding Association has donated a free copy of its new beginner's guide, *Let's Go Birding!* (by Ted Floyd and Bill Schmoker) to each conference attendee.

Attention, Young Birders. We can help with registration costs. Please indicate on your registration form that you are under 18. Speaking of young birders, CFO is delighted that our official artwork for this year's conference is by Saraiya Ruano, a sophomore at Colorado College, and a well-known bird artist and writer.

Colorado Field Ornithologists is pleased to welcome Craig Benkman. Craig is a Professor and Robert B. Berry Distinguished Chair in Ecology in the Department of Zoology and Physiology, University of Wyoming. Before moving to Wyoming in 2004, Craig was on the faculty at New Mexico State University for 11 years. He was an undergraduate at UC Berkeley, completed his M.S with Russell Balda, Northern Arizona University, his Ph.D. with Ronald Pulliam, State University of New York at Albany, and postdoctoral fellowships with Peter Grant, Princeton University, and Dolph Schluter, University of British Columbia. Craig has published about 65 papers, with a recent focus on coevolution between crossbills and conifers, and ecological speciation in crossbills. "The Rise and Fall of Crossbills" is the title of his keynote address.

Registration is available from 5:00 p.m. to 9:00 p.m. on Friday, May, 21st. Walk-in registration is available at this time. Prices are slightly higher for non-members. CFO membership information can be found on the back of the registration form.

Cancellation Policy: A \$10 charge will be applied to all cancellations on or prior to April 15th. There are no refunds for cancellations after April 15th or on pre-paid merchandise orders.

Field Trips: You must be registered for the convention to go on any field trip. Field trips have been planned for all levels of birders, beginner to advanced. All vehicles entering State Parks **MUST** have either a daily or annual State Parks pass. All field trips will depart from the Hilton parking lot. Appropriate passes are required for vehicle entry at many sites. *Please read field trip descriptions carefully. There are extra fees for special trips (always indicated with an asterisk.)*

Convention Arrival Trips - Friday, May 21st (Full-day Trip Arriving at Venue by 5:00 p.m.)

A1- Montrose to Ft. Collins. Meet at 6:30 a.m., at McDonald's (1035 E Main St.).

Convention Trips - Friday, May 21st (Full-day Trips Returning by 5:00 p.m.)

- C1 - Northeast Colorado. Departing at 5:30 a.m., visiting Jumbo Reservoir, Red Lion, Tamarack, and if time permits other locales. Targets include Upland Sandpiper, Field Sparrow, and migrants.
- C2 - Cameron Pass and Jackson County. Departing at 5:40 a.m., visiting Cameron, the visitor's center, and other various locations in Jackson county. Targets include, mountain species, Bald and Golden Eagles, courting Western and Eared Grebes, nesting American White Pelicans and Double-crested Cormorants, California and Franklin's Gull, Forster's Tern, Black-crowned Night-Heron, Snowy Egrets, Willets, Greater Sage-Grouse, and many waterfowl.
- C3 - Red Feather Lakes. Departing at 5:50 a.m., visiting a variety of habitats beginning with Ponderosa Pine and rising in elevation through subalpine and then alpine forest. Targets include Dusky Grouse, Williamson's Sapsucker, American Three-toed Woodpecker, Olive-sided Flycatcher, Fox Sparrow, Veery, and Sandhill Crane.
- C4 - Mountain Pine Beetle. Leader: Dave Leatherman (former forest entomologist for the CO State Forest Service). Departing at 6:00 a.m., visiting the Cameron Pass area. Hands-on investigation of a mountain pine beetle-infested area. Discuss the implications of such natural disturbances for the forest and observe birds in the area. A particular target of the trip will be American Three-toed and Hairy Woodpeckers. Participants are encouraged to bring a hatchet if they have one.
- C5 - The Pawnee. Departing at 6:05 a.m., visiting Crow Valley, Pawnee, Jackson Reservoir, and Weldona. Targets include Mountain Plover, longspurs, and migrants.
- C6 - Cheyenne and Pine Bluffs. Departing at 6:10 a.m., visiting Lions Park, Hereford Ranch, Pine Bluffs, and the Hwy. 85 corridor. Targets include mostly land migrants and possibly some shorebirds.
- C7 - Greeley area. Departing at 6:20 a.m., visiting Lower 59 Road Pond, Loloff Reservoir, Latham Reservoir, Beebe Draw, and City Parks in Greeley. Targets include prairie birds, land and shorebird migrants.
- C8 - Estes and RMNP. Departing at 6:30 a.m., visiting Lake Estes, and Bear Lake. Dress in layers and be prepared for hiking in snow. Targets include Northern Goshawk, Band-tailed Pigeon, Golden-crowned Kinglet, Red Crossbill, and Pine Grosbeak.
- C9 - Loveland area. Departing at 6:35 a.m., visiting the Big Thompson River trail. Targets include warblers, vireos, flycatchers, American Dipper, and Virginia Rail.
- C10 - Northern Larimer County. Departing at 6:40 a.m., visiting the Watson Lake migrant trap, Wellington Reservoirs, and Soapstone Prairie Natural Area. Targets include Burrowing Owl, Grasshopper Sparrow, Dickcissel, and other prairie species.
- C11 - Slacker Trip. Departing at 8:00 a.m., visiting Poudre River Trail, Environmental Center, and Dixon Reservoir. Targets include Green Heron, Blue Grosbeak, and Orchard Oriole.

C12 - Cameron Pass and Jackson County (see C2). Departing at 5:40 a.m.

C13 - Red Feather Lakes (see C3). Departing at 5:50 a.m.

C14* - Special Field Trip! Phantom Canyon Preserve. Departing at 6:00 a.m., this spectacular private holding of The Nature Conservancy (TNC) ordinarily has limited public access. TNC has graciously provided access to CFO conference attendees. Phantom Canyon is one of the largest roadless river canyons on the Front Range, and the scenery is spectacular. We will bird in riparian, montane grassland and shrubland habitats with great potential for breeders, and migrants. CARPOOLING WILL BE REQUIRED THROUGH THE NEIGHBOR'S LOCKED GATE. This trip will require moderate climb up out of the canyon- 600' elevation gain in 8 tenths of a mile. Leaders will be TNC staff and Ted Floyd. \$10 additional fee.

C15 - The Pawnee (see C5). Departing at 6:05 a.m.

C16 - Cheyenne and Pine Bluffs (see C6). Departing at 6:10 a.m.

C17 - Breeding Bird Atlas Trip. Departing at 6:15 a.m., visiting an unassigned block nearby.

- C21* - Private Ranch in Larimer County. Departing at 6:40 a.m., Meadow Springs is a 25,000 acre ranch owned and managed by the City of Fort Collins Utilities Department. There is normally no public access to this property. The ranch supports nesting mountain plovers, burrowing owls, ferruginous hawks, McCown's and chestnut-collared longspurs, grasshopper sparrows and at least 90 other breeding and migratory bird species in addition to other prairie wildlife. \$10 additional fee.
- C22 - Northern Larimer County (see C10). Departing at 6:45 a.m.
- C23 - Slacker Trip (see C11). Departing at 8:00 a.m.

- C36 - Slacker Trip! Bare-naked Birding with Ted Floyd. Join us at the decadent hour of 9:00 a.m. We will carpool a very short distance from the hotel to a birding spot right in Fort Collins. We won't even use our binoculars! Seriously. In fact, you are prohibited from using them. In this fun workshop, Ted will guide us in all the ways we can observe birds without binoculars. We will learn all about gestalt, behavior, microhabitat cues, and so forth. Back by lunch! We'll probably find some annoyingly good bird that all the other trips don't!
